Requests to address the council or to be on the agenda must be given to the city clerk no later than noon (12:00) on the Wednesday preceding a scheduled council meeting (council meetings are scheduled for the second and fourth Monday of every month).

#### Regular Meeting City Hall, Marysville, Kansas-February 12, 2024

Members of the Governing Body of the City of Marysville were called to order in the regular session at 7:00 p.m. on the date and place noted above with Mayor Frye in the chair. Interim City Administrator Pederson and City Clerk Holle were also present.

After the Pledge of Allegiance, roll call was answered by the following council members: Snellings, Ferris, Behrens, Keating, Beikman, Schrater, Throm and Goracke. A quorum was present.

The minutes from the January 22<sup>nd</sup> regular meeting were presented for approval. CM Throm moved; CM Beikman seconded to approve the minutes as presented. Motion carried by 8-0 voice vote.

The minutes from the January 29<sup>th</sup> special meeting were presented for approval. CM Throm moved; CM Behrens seconded to approve the minutes as presented. Motion carried by 8-0 voice vote.

#### **PUBLIC COMMENTS:**

1. CHAMBER MAIN STREET REPORT. Wayne Kruse, Director of Chamber Main Street gave an update on local events. Wayne said he has been researching other cities who have revitalized living spaces in their downtowns.

Mayor Frye asked to amend the agenda to add appointments. CM Throm moved, CM Schrater seconded to add appointments for a City Attorney, City Judge and City Prosecutor. Motion carried unanimously.

#### **BUSINESS AND DISCUSSION ITEMS:**

- 1. LANDOLL STORMWATER MANAGEMENT PLAN PROPOSAL FOR SHOP 100. BI Ralph included in the agenda a storm water management plan for Landoll's proposed new Shop 100. The engineer included a detailed plan for Council review and approval. The Planning and Zoning Commission has reviewed the plan. CM Beikman moved; CM Throm seconded to approve the storm water management plan for Landoll Shop 100 located at 1065 Pony Express Highway. Motion passed 7-0-1. CM Keating abstained as he is an employee of Landoll's.
- 2. ALLEY COSTSHARE BLUE RIVER EYECARE. Kurt Olson, owner of Blue River Eye Care is rehabilitating the building at 715 Broadway. The alley is between Broadway and Elm and between 7th and 8th Street. The project will require part of the alley to be removed to accommodate a new sewer and electrical service. Mr. Olson would also like to connect the building run off with an underground pipe to the City's storm sewer. The City will write an agreement with Blue River Eye Care specifying the property owner will retain responsibility for the pipe. After the upgrades have been made, instead of only repairing the cuts in the alley he would like to replace 148' of the entire alley. Mr. Olson is proposing the cost to improve the alley be split 50/50 with the City as the alley is City property. CM Snellings moved; CM Throm seconded to approve the proposal with the City's share equaling \$11,100 to be paid from the Sales Tax Fund. Motion carried unanimously.
- 3. POLICE POLICY 219 PROPOSAL. The Police Department is asking the City to approve Policy 219 which allows sworn police officers to exercise on City time on City property for up to 3 hours per week if specified conditions are met. Completion of an annual physical is required. CM Schrater moved; CM Ferris seconded to approve General Health and Physical Fitness Policy 219. Motion carried unanimously.

# ICA Pederson wrote a Request for Development Proposal for the Koester Block commercial buildings. The goal of the City is long term preservation of the building structures, preservation of the architectural and historic integrity of the buildings, expand living opportunities in downtown Marysville maintain and improve street-level commercial spaces.

4. SALE/LEASE AND DEVELOPMENT KOESTER BLOCK COMMERCIAL BUILDINGS.

opportunities in downtown Marysville, maintain and improve street-level commercial spaces. Proposals will be evaluated, and the successful developer will be chosen by the City Council. The proposals are due by April 15, 2024. CM Snellings moved, CM Goracke seconded to approve the RFP for the Koester Block Commercial Properties. Motion carried unanimously.

5. CDBG GRANT FOR LAGOON EXTENSION. The design phase of the Lagoon/Wetland Project took longer than originally projected. Therefore, the construction phase did not begin on time. The City is requesting an extension with the Department of Commerce so the CDBG Funds will not be lost. CM Throm moved, CM Snellings seconded to request an extension from March 14, 2024, to June 14, 2024. Motion carried unanimously.

#### **NOTICES AND HEARINGS:**

**CONSENT AGENDA.** The Consent Agenda was presented for consideration. CM Throm moved; CM Beikman seconded to approve the Consent Agenda. Motion carried unanimously. Consent Agenda consisted of the following:

- 1. Request for payment of CDBG Funds grant 22-PF-025 \$170,000.00.
- 2. Alcohol Consumption-Lee Dam Art Center-MCAC February 17, 2024- Culinary Arts.
- **3.** The City Clerk's Report for January showed \$87,214.91 collected in receipts with a like amount being deposited with the City Treasurer.
- **4.** Cash balances in funds were presented as well as outstanding debt and receivable balances. Revenue/Expenditure Budget Reports through January 2024 showed unadjusted accumulated revenues in the General Fund of \$1,163,946 or 40% of budget; Water Revenue Fund, \$63,879 or 7% of budget, Sewer Revenue Fund, \$65,040 or 8% of budget. Unadjusted statement of expenditures in the General Fund totaled \$179,600 or 5% of budget, Water Revenue Fund, \$52,273 or 4% of budget, and Sewer Revenue Fund, \$68,679 or 5% of budget.
- 5. The Municipal Judge's Report for January showed \$3,809.25 being deposited with the City Treasurer and \$391.00 being forwarded to the State Treasurer for Judicial Branch Education, court costs and law enforcement training.

#### APPROPRIATIONS ORDINANCE NO. 3816

1. Claims against the funds of the City were submitted for Council consideration as follows: General Fund, \$319,730.09; Water Revenue Fund, \$50,068.68; Sewage Revenue Fund, \$56,282.17; Street & Highway, \$20,023.88; Library Revolving Fund, \$12,922.39; Library Fund, \$127,151.38; Library Employee Benefit Fund, \$44,429.62; Swim Pool Sales Tax, \$25,322.03; Koester Block Maintenance, \$1,673.93; Employee Benefit Fund, \$20,344.01; Transient Guest Tax, \$3,586.22; Municipal Equipment Reserve, \$36,305.00; Sales Tax Improvement Fund, \$33,749.65 making a total of \$751,589.05.

- **2.** An appropriations ordinance was introduced and considered to honor claims against the funds of the City as audited by the Finance Committee. CM Throm moved; CM Snellings seconded to approve the appropriations ordinance totaling \$751,589.05.
- **3.** Motion to approve the appropriations ordinance carried by 8-0 roll call vote. City Clerk Holle assigned Ordinance No. 3816.

#### **STAFF REPORTS:**

#### 1. INTERIM CITY ADMINISTRATOR.

- 1. AGENDA. ICA Pederson explained the Order of Business of the agenda and how each procedure should work. He noted staff reports are used by the City Administrator and/or the City Clerk for items requiring discussion or approval. Standing Committee Reports are items for reports from committees who have met. Round Table Discussion has been re-named to Council Comments. It is for informal questions or follow-up from previous discussions if needed.
- **2. ADA PARKING SPACES**. ICA Pederson reported that the ADA parking spaces on Broadway and the side streets downtown are not in compliance. Handi-cap spots on city streets need to be 20 feet wide and cannot be within 20 feet of a crosswalk. The City needs to work on becoming compliant with federal regulations.
- **3. VEHICLES ON LEVEE ROAD.** The access road for the levee and Ferry Park has given access to vandals. This road may need to be closed to the public.
- **4. NORDHUS STORM SEWER.** Jadwin Construction is working on the storm sewer collapse behind Bite Me Barbeque which causes the storm water to back up on Center Street near Nordhus Motors.
- **5. CAPITAL FUNDING.** The Sales Tax Improvement Fund generates approximately \$1,000,000 per year. \$400,000 is used to support the General Fund and the remainder of the funds could be used to pay a bond used for street repairs.
- **6. WATER PROJECT ON 8<sup>TH</sup> AND ELM.** Jadwin Construction is testing the new water main for the Elm Street project. They should be able to make the cutover shortly.

#### STANDING COMMITTEE REPORTS:

**APPOINTMENTS:** Mayor Frye made the following appointments: *Marysville Library Board:* Dexter Spitsnogle, February 2024 through April 2025; replacing Pat Schramm who resigned and Jamie Anderson, April 2024 through April 2028. CM Throm moved; CM Snellings seconded to approve the Mayor's appointments. Motion carried unanimously.

City Attorney and Judge positions: City Judge-John McNish; City Attorney and City Prosecutor-Aaron Westbrook. CM Throm moved; CM Behrens seconded to approve the Mayor's appointments. Motion carried unanimously.

**EXECUTIVE SESSION:** At 8:02 p.m. CM Beikman moved to recess in executive session to discuss personnel matters, not general personnel policies, exception KSA 75-4319 (b) (1). This session will include the Mayor, City Council, and the interim City Administrator. The open meeting will resume in the city council chamber at 8:07 p.m. CM Throm seconded. Motion carried 8-0. At 8:07 p.m. the council reconvened. Mayor Frye reported no binding action was taken during the executive session and the regular session was continuing. Mayor Frye reported the City would be moving forward in the administrator search and ICA Pederson had completed his time here. The City may use Mr. Pederson on a contract basis in a consulting role.

#### **COUNCIL COMMENTS:**

- YARD DAMAGE. CM Snellings reported Eric and Sandi Wilson had spoken to her about damage
  to their yard during snow removal. CC Holle said they had reported it to the City, and it will be
  addressed.
- 2. JAKE BRAKES. CM Ferris said people were complaining that jake brakes are used in Marysville and the regulation is not being enforced. New signage was discussed. ICA Pederson said he spoke with PC Simpson and there may be some issues enforcing the jake brake policy. Noisy vehicles are also a problem and the Mayor suggested educating people should be the first step.
- 3. MLNARIK CONDEMNATION. CM Behrens asked if the City can proceed with the condemnation of Walter Mlnarik's house at 205 Calhoun. He has been burning again and the improvements required have not been made. Staff will check on the appeal he filed in district court.
- **4. FIRE DEPARTMENT PUMPER TRUCK.** CM Beikman said the fire chief reported to him pumper truck 602 has been sent to Danko for repair.
- **5. SNOW ROUTES.** CM Throm asked if a new ordinance should be written about snow removal because the current ordinance is not enforceable.
- **6. STORM SIREN.** CM Schrater made a motion to reconsider the storm siren near Keystone Addition, CM Snellings seconded. Motion carried unanimously. After council discussion CM Keating moved, CM Snellings seconded to purchase a new siren for the Keystone area for \$43,746.75. Motion carried unanimously.
- 7. CITY ADMINISTRATOR CANDIDATES, Mayor Frye announced there will be a Meet and Greet for the public at the Lee Dam Art Center on Wednesday, February 28<sup>th</sup> from 4:30 to 6:00 p.m. to meet the candidates for the City Administrator position. There are three candidates, and their names will be released on Tuesday, February 27. The Council and department heads will conduct interviews on Thursday, February 29 and a special meeting will be held at 4:00 p.m. to hire an administrator.

There being no further business, at 8:36 p.m. CM Throm moved to adjourn, CM Goracke seconded. Motion carried unanimously.

#### SPECIAL MEETING

City of Marysville, Marysville, Kansas, February 15, 2024

Members of the Governing Body of the City of Marysville were called to order in a special meeting at 5:30 p.m., on the date and at the place listed above with Mayor Frye opening the meeting. City Clerk Holle was also present.

Council members answering present to roll call were Ferris, Behrens, Keating, Beikman, Schrater, and Goracke. A quorum was present. CM Snellings and CM Throm were absent.

The call, signed by six of the six council members present, read as follows:

We, the undersigned councilmembers of the City of Marysville hereby respectfully request that you call a special council meeting of the members of the governing body of said City to be held at 5:30 p.m. on Thursday February 15, 2024, at the Marysville City Hall for the following purpose:

- a) Appoint Andrew Lohmann City Prosecutor.
- b) Discuss the Storm Sewer Project near Nordhus Motors.

Mayor Frye said Aaron Westbrook declined the City Prosecutor position and he would like to appoint Andrew Lohmann as City Prosecutor. CM Behrens moved; CM Beikman seconded to approve the appointment of Andrew Lohmann as City Prosecutor. Motion carried unanimously.

CC Holle presented two preliminary designs from CES to repair the storm water issue on Center Street near Nordhus Motors. Option 1 brought the storm water from 15<sup>th</sup> and Carolina and then to the middle of Center Street on the north side in front of Nordhus Motors. It then connected to a new pipe installed behind Bite Me BBQ where the existing pipe collapsed. The cost of Option 1 is estimated to be between \$616,377 and \$795, 240. Option 2 brought the storm water from 15<sup>th</sup> and Carolina and then runs on the north side of Center Street to 14<sup>th</sup> Street and south to the large storm sewer pipe. The estimated cost of Option 2 is between \$962,453 and \$1,255,733. Water Supervisor Bargman explained the situation with the collapsed pipe. He also suggested adding 2 additional catch basins on the south side that would dump into the existing manhole behind Bite Me BBQ.

Council consensus is to ask for CES to design Option 2 and ask for an estimate of additional catch basins on the south side.

At 5:49 p.m., CM Schrater moved, CM Behrens seconded to adjourn the meeting. Motion carried unanimously.

RE: Revision to HWY 77 Project

Late in 2023, Project Engineer Thaniel Monaco brought forward to the Interim City Administrator the prospect of abandoning an existing 8" sewer line that crosses HWY 77 & Jackson and re-directing 3 existing residential service lines on that section of main to a newer 12" interceptor sewer main located in the same area. By doing this conversion, replacement of 381 feet of 8" sewer line becomes unnecessary, and the City will be relieved of long-term maintenance of the abandoned main.

Monaco has furnished the City with a modified construction cost for eliminating the 8" sewer replacement that results in a deduct of \$33,110. The entire savings from this would accrue to the City as sanitary sewer costs in the project are borne entirely by the City.

In eliminating this cost and abandoning the existing 8" line, three private residential service lines will need to be replaced at City expense. A quote for this work has been obtained from Jadwin Construction (attached) in the amount of \$23,977.31. Savings to the City by making this switch amounts to \$9,133, based upon the quote received on February 21. That quote is good for only 30 days and may increase once the work is actually accomplished.

At this time, authorization from the Council is requested to direct BG Consultants to make this design change to the project scope so that it can be made before design is complete and the project goes to bid. The contract with Jadwin for installation of the three replacement service lines will be finalized once the timeline for project construction is determined.

On a related note, it has not yet been determined if the 18" storm sewer line on the West side of HWY 77 from Oak to the inlet North of North Park Drive will need to be replaced. The estimated cost to replace it is \$72,400. If this needs to be done, a similar change in project scope will need to be authorized by the City Council.

# **City Council Staff Report**

**Subject:** Jake Brakes or Compression Brakes

#### **History:**

In 2002, the City of Marysville adopted Ordinance No. 1599 (Attachment #1), which was first published on August 1, 2002.

Under Ordinance No. 1599, city code was amended and stated:

- 14-225(a) It shall be unlawful for any person operating a motor vehicle within the limits of the City of Marysville, KS, to use or operate or cause to be used a jake brake system or compression brake system installed in said vehicle.

In 2023, the City of Marysville adopted Ordinance No. 1921 (Attachment #2), which was first published on August 31, 2023.

Under Ordinance No. 1921, city code was amended and states:

- 14-101 Incorporating Standard Traffic Ordinance....
- Section 2. Ordinance 1908 and all other ordinances or parts of ordinances in conflict herewith be and they are hereby repealed. This hereby repeals Ordinance 1599, City Code 14-225(a) as it conflicts with the 2023 Edition of the Standard Traffic Ordinance for Kansas Cities.

Therefore, we operate under the 2023 STO Manual.

The 2023 Edition of the Standard Traffic Ordinance for Kansas Cities adopted by council, states:

 Sec. 175.1 It shall be unlawful for the driver of any motor vehicle to use or cause to be used or operated any compression release engine braking system without such motor vehicle being equipped with a muffler in accordance with Section 175. (Attachment #3)

#### Issue at Hand:

Under the 2023 Edition of the Standard Traffic Ordinance for Kansas Cities adopted by council, jake brakes or compression brakes are lawful if the vehicle is equipped with a muffler.

For example, the Marysville Fire Department operates a truck that must be utilized with a jake brake due to the amount of water the truck carries. It is equipped with a muffler.

In my training and experience, nearly every large truck is operated with some type of muffler system. Therefore, they are in accordance with the 2023 Standard Traffic Ordinances.

#### **Summary Recommendation:**

1) If the council wishes for Ordinance No. 1599 published in 2002 to be in effect, then the adoption of the 2023 Standard Traffic Ordinance under Ordinance 1921 should have removed Section 175.1 of the STO manual.

I've attached a STO Ordinance adoption example from another municipality, exempting the STOs that conflict with city ordinances strictly for an example to reference. (Attachment #4)

It is my recommendation that all STO Manual adoptions in the future be examined against city ordinances prior to adopting it, and those STOs that conflict with city ordinances be exempted from the new STO manual as shown in Attachment #4.

- Emergency vehicles should be exempted from the ordinance. If Ordinance No. 1599 was in effect, one of the Marysville Fire Department trucks would be operating in violation of the law.
- 3) The city should consider not adopting a new STO manual every year and move to updating the STO manual every 2-4 years as necessary. It is my opinion that updating the STO manual yearly is costly, unnecessary and leads to conflicting ordinances such as described above.

#### **ORDINANCE NO. 1599**

AN ORDINANCE AMENDING SECTION 14-225 TO THE 1987 CODE OF THE CITY OF MARYSVILLE RELATING TO ENGINE BRAKING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MARYSVILLE, KANSAS:

Section 1. That Section 14-225 of the 1987 Code of the City of Marysville, Kansas, is hereby amended to read as follows:

- 14-225. COMPRESSION BRAKES; DESCRIPTION. The term "jake brake" or "compression brake" as used herein means any device commonly known by either name or any similar device used to slow a motor vehicle by engine compression creating loud or excessive noises to be emitted through the vehicle's exhaust system.
  - (a) It shall be unlawful for any person operating a motor vehicle within the limits of the City of Marysville, KS, to use or operate or cause to be used a jake brake system or compression brake system installed in said vehicle.
  - (b) PENALTY. Any person convicted of a violation of this Ordinance may be punished by a fine of not more than \$250.00.

Section 2. Ordinance No. 1569 and all other ordinances or parts of ordinances in conflict herewith, be and they are hereby repealed.

Section 3. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

#### ORDINANCE NO. 1921

AN ORDINANCE AMENDING SECTION 14-101 OF THE 2020 CODE OF THE CITY OF MARYSVILLE, KANSAS.

#### BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MARYSVILLE, KANSAS:

**Section 1.** Section 14-101 of the 2020 Code of the City of Marysville hereby is amended to read as follows:

14-101. INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Marysville, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities," edition of 2023, prepared and published in book form by the League of Kansas Municipalities, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of the Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1921," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the city charged with enforcement of the article shall be supplied, at the cost of the city, such number of official copies of the Standard Traffic Ordinance similarly marked, as may be deemed expedient.

**Section 2.** Ordinance 1908 and all other ordinances or parts of ordinances in conflict herewith be and they are hereby repealed.

**Section 3.** This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

Lucinda Holle City Clerk (f) Every truck designed and used for collection and disposal of domestic or commercial waste or trash shall be equipped with vehicular hazard warning signal lamps for the purpose of warning the operators of other vehicles of the presence of a vehicular traffic hazard requiring the exercise of unusual care in approaching, overtaking or passing. Hazard warning signal lamps used to display such warning to the front shall be mounted at the same level and as widely space laterally as practicable and shall display simultaneously flashing amber lights. On any vehicle manufactured prior to January 1, 1969, the lamps showing to the front may display simultaneously flashing white or amber lights, or any shade of color between white and amber. The lamps used to display such warning to the rear shall be mounted at the same level and as widely spaced laterally as practicable, and shall show simultaneously flashing amber or red lights, or any shade of color between amber and red. Such warning lights shall be visible from a distance of not less than 500 feet in normal sunlight. (K.S.A. 8-1722)

#### Sec. 175. Noise Prevention; Mufflers.

- (a) Every vehicle shall be equipped, maintained and operated so as to prevent excessive or unusual noise. Every motor vehicle at all times shall be equipped with a muffler or other effective noise suppressing system in good working order and in constant operation, and no person shall use a muffler cutout, bypass or similar device.
- (b) The engine and power mechanism of every motor vehicle shall be so equipped and adjusted as to prevent the escape of excessive fumes or smoke. (K.S.A. 8-1739)

#### Sec. 175.1. Compression Release Engine Braking System.

- (a) It shall be unlawful for the driver of any motor vehicle to use or cause to be used or operated any compression release engine braking system without such motor vehicle being equipped with a muffler in accordance with Section 175.
- (b) As used in this section, "compression release engine braking system" means a hydraulically operated device that converts a power producing diesel engine into a power absorbing retarding mechanism. (K.S.A. 8-1761)

#### 10.15.020 Amendments.

- (b) Section 50 of the Standard Traffic Ordinance, relating to right, left and U-turns at intersection obedience to, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC 10.20.180, 10.20.190, 10.20.210, and 10.20.220 shall be substituted therefor.
- (c) Section 67 of the Standard Traffic Ordinance, relating to pedestrians to use right half of crosswalks, is hereby declared to be and is omitted and deleted.
- (d) Section 69 of the Standard Traffic Ordinance, relating to pedestrians soliciting rides or business, is hereby declared to be and is omitted and deleted and the provisions set forth in Chapter 10.80 TMC shall be substituted therefor.
- (e) Section 104 of the Standard Traffic Ordinance, relating to inattentive driving, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC 10.20.100 shall be substituted therefor.
- (f) Section 107 of the Standard Traffic Ordinance, relating to unattended motor vehicles, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC 10.20.125 shall be substituted therefor.
- (g) Section 116 of the Standard Traffic Ordinance, relating to driving upon sidewalks, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC 10.20.127 shall be substituted therefor.
- (h) Section 119 of the Standard Traffic Ordinance, relating to parades and processions, is hereby declared to be and is omitted and deleted and the provisions set forth in Chapter 10.50 TMC shall be substituted therefor.
- (i) Section 131(d) of the Standard Traffic Ordinance, relating to usable bicycle paths, is hereby declared to be and is omitted and deleted.
- (j) Section 133(c), relating to bicycle pedals, is hereby amended by adding the following exception:

Exception: Subsection (c) shall not apply where the design of the pedal does not allow attachment of reflectors.

(k) Section 194(b) and (c) of the Standard Traffic Ordinance, relating to driving while license canceled, suspended or revoked, is hereby declared to be and is omitted and deleted.

- (l) Section 195.1 of the Standard Traffic Ordinance, relating to operation of a motor vehicle when a habitual violator, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC  $\underline{10.20.230}$  shall be substituted therefor.
- (m) Section 198 of the Standard Traffic Ordinance, relating to vehicle license illegal tag, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC 10.05.060 shall be substituted therefor.
- (n) Section 204(b) of the Standard Traffic Ordinance, relating to fines doubled in school zones, is hereby declared to be and is omitted and deleted and the provisions set forth at TMC  $\underline{10.20.170}$  shall be substituted therefor. (Ord. 20375 § 2, 9-13-22.)
